

Library, Equipment, Repair, and Rehabilitation (LERR) Funds Overview

All funds awarded through these programs must be expended within 36 months of the award date. Encumbrances will not hold the award balance upon expiration. Long lead-time purchases should be made in time to be fully received and paid for prior to the expiration date of the award. All funds not expended by the expiration date will be lapsed and returned to UT System for reallocation. Clear, itemized documentation must be attached to all requisitions associated with these programs.

LERR awards are usually made specifically for library and equipment purchases or repair and rehabilitation projects to specific areas or buildings. Expenditures must be made for the UT System Board-approved purpose of the award.

Final approval of specific Repair and Rehabilitation projects will be in accordance with the U. T. System Board of Regents established procedures for construction projects.

Allowable Costs

Major repair and rehabilitation of buildings or other permanent improvements

- May include repairs to roofs or building facades and infrastructure improvements.

Acquiring capital equipment having a useful life of more than one year and library books and materials

- Equipment cost may include all cost necessary to place the item into service including:
 - Attachments and accessories
 - Installation and delivery costs
 - In-transit insurance, taxes, and duty costs

The following list summarizes the allowable expenditures for these limited purpose funds.

- Operating costs such as maintenance, training, travel, or communications costs.
